The main responsibilities of the post holder will be

- To facilitate and support in data collection/ analysis leading to internationally excellent research outputs.
- To support in writing external/ competitive grant applications.
- To engage in dissemination and public engagement activities.

Main Activities

- a) To carry out internationally excellent research as directed by and in conjunction with senior research staff.
- b) To undertake relevant data collection at the international partner organisation using quantitative and qualitative methods, taking a lead role in the day-to-day research activities.
- c) Perform statistical analyses in SPSS.
- d) To conduct systematic reviewing of literature and where appropriate meta-analysis of relevant data sets.
- e) To support preparation of ethical approval submissions both at the University and with HRA.
- f) Where appropriate, to liaise with external partners such as health professionals and NHS based organisations, professional bodies and individual practitioners.
- g) To take responsibility for the collection, analysis and synthesis of data and to work in closely with the international partner.

- h) To prepare concise research reports and present data in a clear and logical manner.
- i) To contribute to the dissemination of research outcomes/ findings.
- j) To undertake other such responsibilities as may reasonably be required by the line-manager or Dean.

Special Conditions

The post involves considerable international travel and it requires the postholder to spend significant amount of time conducting research at partner organisations outside the UK.

This post is fixed term from 01 August 2019 to 15th February 2020.
